#### RESOLUTION NO. NS-30,077

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SANTA CRUZ CONFIRMING AND APPROVING THE CANVASS OF BALLOTS AND RETURNS FOR THE CITY OF SANTA CRUZ GENERAL ELECTION HELD ON NOVEMBER 8, 2022 AND DECLARING THE RESULTS

WHEREAS, at the meeting of June 28, 2022 the City Council adopted Resolution No. NS-30,016 calling for an election in the City of Santa Cruz for the purpose of placing two citizen initiative measures on the ballot – The Empty Homes Tax (Measure N) and Our Downtown, Our Future (Measure O); and

WHEREAS, at the meeting of August 9, 2022, the City Council adopted Resolution Nos. NS-30,019 and NS-30,025 for the purpose of place a measure on the ballot – Transient Occupancy Tax (Measure P) and electing Councilmembers for Districts 4 and 6, and Mayor; and

WHEREAS, on November 8, 2022, the election so called and ordered was held in accordance with law and the votes were counted; and

WHEREAS, the County Clerk has certified the results of the election.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Santa Cruz that it hereby certifies the following:

- 1. The General Election referred to above was held in the City of Santa Cruz on November 8, 2022.
- 2. The certified canvass of returns is set forth in Exhibit "A" and incorporated by reference.
- 3. A citizen initiative ballot measure proposing an ordinance adding Chapter 3.38 to the City's Municipal Code to establish an Empty Homes Tax was submitted to the voters and the votes were cast for and against the measure as follows:

A majority of the votes cast were against this ballot measure, therefore the measure (Measure N) failed.

4. A citizen initiative ballot measure to amend the City's General Plan and Downtown Plan was submitted to the voters and the votes were cast for and against the measure as follows:

A majority of the votes cast were against this ballot measure. The measure (Measure O) failed.

5. A ballot measure to approve an increase to the City's Transient Occupancy Tax (TOT) was submitted to the voters and the votes were cast for and against the measure as follows:
