RETITION FOR RECALL

TO THE HONORABLE SANTA CRUZ CITY COUNCIL.

Pursuant to the California Constitution and California election laws, we the undersigned registered and qualified electors of the City of Santa Cruz, California, respectfully state that we seek the recall and removal of Drew Glover, holding the office of Councilmember in Santa Cruz, California. We demand an election of a successor to that office. The following Notice of Intention to Circulate Recall Petition was served on June 5, 2019 to Drew Glover.

NOTICE OF INTENTION TO CIRCULATE RECALL PETITION

TO THE HONORABLE DREW GLOVER,

Pursuant to Section 11020, California Elections Code, the undersigned, registered qualified voters of The City of Santa Cruz, in the State of California, hereby give notice that we are the proponents of a recall petition and that we intend to seek your recall and removal from the office of City Council, in Santa Cruz, California, and to demand election of a successor in that office.

The grounds for the recall are as follows:

Councilmember Glover has endangered public health and safety by repeatedly voting against closure of the Ross Camp. He participated on behalf of the plaintiffs in a federal suit against the City to keep the Ross Camp open. In a sworn declaration, Glover falsely claimed that there was no health and safety risk at the Ross Camp, contradicting the Fire Chief and County Health Officer. Glover has failed to pursue safe, humane, legal, and realistic solutions to homelessness in the City of Santa Cruz.

Councilmember Glover has repeatedly attempted to establish permanent homeless encampments and overnight RV parking sites in residential neighborhoods and city parks, without regard for public safety, and without consulting the Fire Department, Police Department, or neighborhood residents.

Councilmember Glover has introduced a culture of chaos, bullying and disruption to public meetings and general City business. His actions as a Councilmember, including walking out of two active City Council sessions, fail to meet basic standards of conduct. He has failed to foster positive and productive relationships with council peers and City staff. Glover has demonstrated through his actions and temperament that he is unfit to serve as a Councilmember of the City of Santa Cruz.

No politician has ever made everybody happy. I can't claim to make the impossible happen, but I can ensure that every voice is heard, to the best of my abilities.
