Mr. Sonnenfeld made the following motion, seconded by Mr. Lane who had friendly amendments, accepted Mr. Sonnenfeld:

Request to the City Council that the CACH expand by one individual, with the CACH determining the nomination criteria

Motion voted and passed with majority

Mr. Tait moved to recommend the Louden Nelson restrooms remain open only to patrons of Louden Nelson. Seconded by Mr. Lane seconded Motion carried by vote (8)

Mr. Tait moved to propose two (2) additional ADA porta potties be added to the downtown area that would be open 24/7. Seconded by Mr. Lane *Motion adopted by consensus*

Mr. Tait moved that the CACH recommend to the City Council that an additional homelessness coordinator staff position be created. Seconded by Mr. Lane seconded. Mr. Kagno moved to table.

Motion to table passes (6)

Safe Camping Subcommittee reported (8:23 pm)

Mr. Sonnenfeld moved to recommend relocating the shuttle pick-up site for the Laurel Street shelter program to an indoor or sheltered location. Adopted by consensus

Mr. Sonnenfeld moved to recommend the creation of an additional managed low barrier, ADA accessible emergency shelter program in the sphere of influence of the city (either in the city limits or with a shuttle service from the city to the shelter) to be opened this winter. Friendly amendment "to include regular neighborhood meeting between the community and program management"

Amendment was adopted by consensus

Mr. Sonnenfeld moved to recommend the creation of an additional RV sewage dumping site somewhere in the City limit.

Adopted by consensus

Mr. Sonnenfeld moved to recommend the City continue to help fund the shelter program by supporting the County to write a new contract with the Salvation Army to continue services.
