#### ORDINANCE NO. 2023-07

### AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF SANTA CRUZ AMENDING CHAPTERS 10.52 OF THE SANTA CRUZ MUNICIPAL CODE RELATING TO PARKING RATES IN THE CENTRAL BUSINESS DISTRICT

BE IT ORDAINED By the City of Santa Cruz as follows:

Section 1. Section 10.52.210 of Chapter 10.52 is hereby amended as follows:

## 210.52.210 PARKING METER RATE 1- CENTRAL BUSINESS DISTRICT – TWO-HOUR VARIABLE RATE.

### For 2023:

First Hour \$2.25 Second Hour \$2.25 Each Additional Hour \$4.50

A variable rate is established on the following streets:

- (1) Cathcart Street, between Front Street and Cedar Street.
- (2) Church Street, between Pacific Avenue and Cedar Street.
- (3) Cooper Street, between Pacific Avenue and Front Street.
- (4) Elm Street, between Pacific Avenue and Cedar Street.
- (5) Lincoln Street, between Pacific Avenue and Cedar Street.
- (6) Locust Street, between Pacific Avenue and Cedar Street.
- (7) Maple Street, between Pacific Avenue and Cedar Street.
- (8) North Pacific Avenue, between Water Street and Bulkhead Street.
- (9) Soquel Avenue, between Pacific Avenue and Front Street.
- (10) Walnut Avenue, between Pacific Avenue and Cedar Street.

The parking meter rates may be increased by twenty-five cents per hour based on vehicle occupancy on any block or set of blocks during the hours of parking meter operation if occupancy is eighty-five percent or above between the hours of 12:00PM - 4:00 PM on Wednesdays. Rates shall be adjusted for any particular block or set of blocks not more than once every twenty-eight days with a maximum rate of five dollars per hour.

### Section 2. Section 10.52.215 of Chapter 10.52 is hereby amended as follows:

# 210.52.215 PARKING METER RATE 2- CENTRAL BUSINESS DISTRICT – TWO-HOUR VARIABLE RATE.

### For 2023:

First Hour \$2.25 Second Hour \$2.25 Each Additional Hour \$4.50

A variable rate is established on the following streets:

- (1) Bulkhead Street, between North Pacific Avenue and Water Street.
- (2) Cedar Street, between Center Street and Laurel Street.
- (3) Center Street, between Chestnut Street and Elm Street.
- (4) Chestnut Street, between Center Street and Squid Row.
- (5) Church Street, between Cedar Street and Lot No. 6.
- (6) Front Street, between Water Street and Laurel Street.
- (7) Knight Street, between North Pacific Avenue and Water Street.
- (8) Lincoln Street, between Cedar Street and Washington Street.
- (9) Locust Street, between Cedar Street and Center Street.
- (10) River Street South, between River Street and Soquel Avenue.
- (11) Union Street, between Cedar Street and Center Street.
- (12) Walnut Avenue, between Cedar Street and Center Street.
- (13) Water Street, between Front Street and River Street.

The parking meter rates may be increased by twenty-five cents per hour based on vehicle occupancy on any block or set of blocks during the hours of parking meter operation if occupancy is eighty-five percent or above between the hours of 12:00PM - 4:00 PM on Wednesdays. Rates shall be adjusted for any particular block or set of blocks not more than once every twenty-eight days with a maximum rate of five dollars per hour.

Section 3. Section 10.52.220 of Chapter 10.52 is hereby amended as follows:

# 210.52.220 PARKING METER RATE 3- CENTRAL BUSINESS DISTRICT – TWELVE-HOUR RATE.

For 2023: A rate of one dollar and seventy-five cents is established on the following streets and portions of streets:

- (1) Bulkhead Street, between North Pacific Avenue and Water Street.
- (2) Cedar Street, between Center Street and Laurel Street.
- (3) Center Street, between Chestnut Street and Elm Street.
- (4) Church Street, between Center Street and Lot No. 6.
- (5) Civic Auditorium Parking Lot, Public Parking Lot No. 6.
- (6) Lincoln Street, between Cedar Street and Center Street.
- (7) River Street, between North Pacific Avenue and Front Street.
- (8) River Street South, between River Street and Soquel Avenue.
- (9) Walnut Street, between Cedar Street and Center Street.

Section 4. Section 10.52.240 of Chapter 10.52 is hereby amended as follows:

# 210.52.240 PARKING METER RATE 4- CENTRAL BUSINESS DISTRICT – SHORT TERM METERS.

The rate for twenty-minute and thirty-minute time-limit parking meters shall be tied to the rate of neighboring two-hour variable rate parking meters as shown on the chart below:

Two-Hour Variable Meter Rate	Short-Term Parking Meter Rate
\$2.25/hour	\$2.25/hour
\$1.75/hour	\$1.75/hour

Section 10. This ordinance shall take effect and be in full force thirty (30) days after final adoption.
