



REVISED Stakeholder Group Engagement Plan July 21, 2023

The California Coastal Commission approved the City of Santa Cruz's Oversized Vehicle Ordinance with several conditions, including creating a Stakeholder Group to help inform and provide input regarding the City's implementation of the new Ordinance.

Purpose: To provide the City with input on the implementation of the Coastal Commission approved, City of Santa Cruz Oversized Vehicle Ordinance (OVO). The Stakeholder Group will discuss the OVO implementation, including issues and challenges of the program, and suggestions for improvement, including the potential for exempting residents/renters and visitors to residents/renters within the City from the OVO.

Stakeholder Membership: Members of the Stakeholder Group will be composed advocates for the unhoused, safe parking program participants, and other affected individuals with the intention of equal representation between unhoused advocates and oversized vehicle parking control advocates.

10 Members of the Stakeholder Group will include:

- 1 RV dweller in the City (not in the safe parking program).
- 1 safe parking participant.
- 3 advocates for the unhoused.
 - 1 Representative from ACLU: Submitted written & provided verbal testimony to the Commission opposing the City's Coastal Development Permit (CDP). Long standing history in the community for advocating for legal positions of the unhoused.
 - 1 Representative from Santa Cruz Cares: Submitted written & provided verbal opposition to the Commission opposing the City's CDP, organized members of the community who opposed the CDP, history of advocating for services for the unhoused.
 - 1 Representative from Disability Rights Advocates: Submitted written testimony to the Commission opposing the City's CDP. Long standing history in the community for advocating for legal positions of people with disabilities.
- 2 housed residents' representatives in impacted neighborhoods.



- o 1 Representative of West Side Santa Cruz where there have been significant issues with long term oversized vehicle parking.
- o 1 East Side Santa Cruz resident where there have been significant issues with long term oversized vehicle parking.

• 3 OVO advocates.

- O 1 Member of Westside Neighbors. Submitted written & provided verbal testimony to the Commission supporting the City's CDP. Advocate since 2018 of regulating overnight RV parking in their neighborhood. Organized members of the community in support of the CDP.
- 1 City-Wide Neighborhood Advocate: One person who volunteers with the City and/or organizes neighbors on issues related to RVs and encampments.
- 1 Businessowner in a location which has been impacted by long-term oversized vehicles. One person who has advocated to the City in support of the CDP and/or submitted testimony to the Coastal Commission in support of the CDP.

Meetings: Stakeholder Group will meet a minimum of four times over the course of a year. Meetings will be held Hybrid. City staff will schedule the meetings with Stakeholder Group feedback. City staff will set the agenda and facilitate the meetings. Staff from relevant departments will be involved in the meeting process (police, parking, homelessness response team and planning).
