

## **Charity Car Wash Volunteer Waiver and Release Agreement**

I and/or my child acknowledge and understand that participating in a charity car wash event and using a car wash kit provided by the City of Santa Cruz may expose me and/or my child to risk of injury. I and/or my child understand that the car wash kits include electrical cords and electrical pump that may cause injury, and even death, in and around water. Additional potential hazards to health and safety include, but are not limited to, injury due to close proximity to vehicles and roads, slippery surfaces, exposure to hazards from uneven pavement, and contaminants.

I understand that any of these risks and perils, both anticipated and unanticipated, may cause injury or death. I, therefore acknowledge that I and/or my child am/are voluntarily participating in this hazardous activity with knowledge of the potential dangers and hazards involved. I hereby agree on behalf of myself and/or my child to accept and assume any and all risk, including the risk of injury, property damage, or death.

I, on behalf of myself and/or my child, hereby release, discharge, hold harmless and indemnify the City of Santa Cruz , its officers, employees, agents or volunteers, and the person(s) owning the private property where the charity car wash event will occur, namely, from and against all damages, loss, claims, suits or action of any kind or nature whatsoever, including attorneys' fees, brought for or on account of any injury, damage, or death resulting or alleged to have resulted from or in any way related to the above-referenced activity, even though that liability may arise out of negligence or carelessness on the part of the persons or entity mentioned above.
I hereby certify that I have carefully read this agreement and fully understand its contents. I further certify my understanding that this agreement constitutes a release of all claims against the City of Santa Cruz and against all others mentioned in the agreement. I further understand and certify that by execution of this agreement I am voluntarily assuming all risk inherent in my and/or my child's participation in the above-referenced activity. I agree that this agreement is binding on my and my child's respective heirs, guardians, legal representatives, and assigns.
In the event of an emergency, I authorize agents of the City of Santa Cruz to secure from any licensed hospital, physician, and/or medical personnel any treatment deemed necessary for my and/or my child's immediate care and agree that I will be responsible for payment of any and all medical services rendered. If I and/or my child am/are injured while participating in the event, I agree to report it to the sponsor and/or to the first aid staff immediately.
I have read and fully understand the above Waiver and Release Agreement and Permission to Secure Treatment.
I also certify that I, as parent/guardian have legal responsibility for this minor participant, do consent and agree to the terms of this agreement on behalf of my minor child relating to my minor child's participation in the charity car wash event, as provided above.
